Course Description (adapted from the official course catalog): This course offers two things: an introduction to the global issue of genocide, ethnic cleansing, and other mass atrocities, and an in-depth look at two ongoing genocides in Asia: in China and in Burma (Myanmar). First, we will study how genocide works: its prerequisites, its warning signs, and how it is carried out. We also review the creation of the term genocide as a new crime in international law after WWII, the UN Genocide Convention, and the checkered history of failing to prevent genocides (Cambodia, Rwanda, etc.), but also some successes. Then, we focus on the new 21st century genocides under way in Xinjiang, China and against the Rohingya in Burma, respectively, analyzing the background, the events, the actors involved, the key role of media and propaganda, and why Burma expels people, while China forces people to be ethnically cleansed *in place*.

You can also add questions that you think should be brought up. Then, post this to Canvas under "Discussions" before class time. This will be noted, but not graded.

* ***In class, electronics like laptops are only allowed for class-related purposes.***

If we find that you drift off, in lectures or in sections, your grade may be affected (because it means you are not participating, and it disturbs fellow students).

After the military coup on Febr. 1, 2021, the Rohingya stalemate continues with the same massive refugee camps in Bangladesh. The Burmese military has also committed further acts of violence to against Rohingya inside Myanmar territory. At the same time, to deflect blame from themselves, the military has tried to blame the entire Rohingya problem on Aung San Suu Kyi — the elected civilian leader whom they have imprisoned since their coup on Febr. 1.

Meanwhile, the ICJ trial against Burma continues (slowly); and even more testimonies have emerged, now including from soldiers (see items above, incl.: 'Kill All You See': In a First, Myanmar Soldiers Tell of Rohingya Slaughter. *New York Times*, Sept. 8, 2020. <https://www.nytimes.com/2020/09/08/world/asia/myanmar-rohingya-genocide.html>).

After the Febr. 1, 2021 military coup, in response to military violence, civilians have set up a shadow government, which now vies with the military junta for legitimacy on the world stage.

The National Unity Government has its own web page, where it has announced support for the Rohingya -- a remarkable change from earlier years when most politicians in Myanmar seemed to accept the military's expulsion of them.

Also, the NUG has launched a "People's War" (a civil war) against the military, apparently with hundreds of casualties on both sides, already in October 2021. *See f.ex.:*

Uyghur genocide: Update Fall 2021:

* After further revelations of mass forced sterilizations and other abuse came to light during 2020, more voices were raised to identify the atrocities as genocide; several governments and Parliaments publicly declared this a genocide (Canada, the UK, the US, Netherlands). Some countries, incl. the US and the EU, adopted limited sanctions against Chinese perpetrators [government officials], and against Chinese companies profiting from forced labor.

* Also, Uyghur activists in exile have proposed a genocide case against China at the UN International Criminal Court.
